## National and Local League Program Planning

The LWVUS board will review all responses from Leagues across the nation then send its final Recommended Program for 2022-2025 for review. The program planning process culminates in the delegates' adoption of the nationwide program at our 2022 convention.

The LWVMC board will follow a similar process. It will take recommendations from members at this meeting and propose a program for 2022-2023 to be voted on at the Annual Meeting in June.

## **January Monthly Meeting**



#### WHY MEASURE A IS SO IMPORTANT

In 2012, voters approved Measure A, which authorized a countywide, one-quarter cent sales tax to support parks, open space, and agricultural land across Marin. Measure A sunsets on March 31, 2022. A community survey conducted last summer found that 80% of respondents favored extending the measure. With these results, the Board of Supervisors (BOS) directed the Marin County Parks Department staff to work toward preparing a renewal measure for the June 2022 ballot.

This tax has generated an average of \$14 million per year over the last nine years. The funds have been used for a range of county open space and parks projects including the following:

- wildfire fuel reduction
- sea level rise adaptation
- county parks maintenance and improvement
- equity programs to ensure access to recreation opportunities
- farmland preservation and acquisition
- assistance to cities, towns, and special districts for management of parks, open space, and recreation

The Parks Department is in the process of developing a revised ordinance and expenditure plan for Measure A. The biggest proposed change is a reduction in the share allocated to agriculture, from 20% to 10%. The proposed plan has proven to be very controversial. Some members of the public have called for eliminating the allocation for agriculture entirely, while others, including several supervisors, have objected to reducing funds for farmland protection.

Further revisions to the plan will be presented to the Parks Commission and Board of Supervisors January 25 and February 1. The deadline for submitting final language for the June ballot is March 11.

We are delighted that Max Korten, Director of Marin County Parks, will be our speaker on January 10. This is a wonderful opportunity for our League members to learn more about plans for Measure A.

#### **MEASURE A STUDY GROUP**

Because of the critical nature of this measure, our League is forming a special Measure A Study Group. We believe it is vital that we have a good understanding of the impact of Measure A funds and what is proposed going forward. Please contact us if you are interested in joining the study group.

#### WHAT IS PROGRAM PLANNING?

Program planning is the grassroots process of recommending and selecting governmental issues for study and agreement in reaching a position. During January and February 2022, local and state Leagues will conduct program planning and make program recommendations in a general membership meeting or a board meeting. Leagues are also asked to share information on how their work will impact the Campaign for Making Democracy Work as well as identify LWVUS positions that they intend to use in education and advocacy. This is a hallmark of the League of Women Voters grassroots' role in study and action.

League program is the education and advocacy platform that we adopt to move our mission forward. Every two years in the months leading up to convention, Leagues around the country meet to review LWVUS program and propose issues for study or action.

#### VOTERS EDGE WEBSITE TEAM

Want to become familiar with candidates in local elections through direct contact, primarily via email and data entry? If so, volunteer for the Voter's Edge team!

**The Voter's Edge website** is a comprehensive, unbiased online voter guide, used by more than 2 million Californians in 2020. It is a project of the League of Women Voters of

California Education Fund and Maplight, which provides design and web structure. All eligible **candidates** are invited to post a profile on Voter's Edge. **Voters** can access their full, personalized ballot and get in-depth information on candidates, measures, and who supports and funds them; check where, when, and how to vote; and keep track of their choices to make voting easier, simply by entering their address.

**Tasks and Commitment:** Under the leadership of the Voter's Edge Marin County Coordinator, you will research candidates' contact information, invite them to participate, and follow-up with them, as needed. The amount of time required will depend on the number of contests, candidates, and team volunteers. We typically begin work three months prior to Election Day, so hope to ascertain and train volunteers in January and February in preparation for the June primary.

#### YOU CAN IMPACT VOTER TURNOUT IN 2022!

The League of Women Voters of Marin County is again partnering with the Marin County Elections Department and the Marin County Office of Education to recruit and train students to serve as Student Elections Ambassadors. The program, which was founded in 2018, has three main objectives:



## LWVC Education Fund Wins Eight National Awards for Get-Out-the-Vote Efforts In the 2020 election

The LWVC Education Fund earned grants to design and execute a cutting-edge digital get-out-the-vote campaign designed to increase voter turnout in 18-24 year olds with a specific focus on young Black and Latino/a/x voters. Working with our partners at Mixte Communications, the TikTok and Snapchat campaign centered the voices of diverse youth content creators to drive their peers to vote. Wildly exceeding even the most ambitious goals, the campaign reached more than six million people and provided a case study in the effectiveness of meeting youth voters where they are, in ways that resonate with them to drive voting and civic engagement.

The campaign has since received a total of eight national awards from the Public Relations Society of America, Hispanic Public Relations Association, and Platinum PR Awards. For a complete list of awards

Speaker: Joana Castro Simonini, Managing Attorney for Canal Alliance



Joana earned her B.A. from the University of California, Berkeley, majoring in History, in 2002 and her J.D. from the University of California, Hastings College of the Law in 2008. During law school, she worked as an internand clinical student at Canal Alliance focusing on U Visa cases and as a fellow, clinical student and research assistant at the Center for Gender and Refugee Studies at Has-

tings, where she gained extensive experience in asylum law. After law school and prior to joining Canal Alliance, Joana was an intern at the International Criminal Tribunal for the Former Yugoslavia in The Hague and worked as a contract attorney for a private firm in Oakland, CA, gaining experience in removal defense. Joana joined Canal Alliance in December 2014 to represent children and youth before EOIR, the asylum office and USCIS. She also worked on U and T Visas cases, VAWA, Naturalization, DACA, Adjustment of Status and TPS applications, family petitions and consular processing. Joana became Managing Attorney in 2017 and directly supervises the attorneys and DOJs. Working closely with the Operations Manager and Supervising Attorney, she determines and oversees the department's legal and operational strategies. Born in Brazil, Joana is a native Portuguese speaker and is fluent in Spanish and English.
