Announcing Guest Speaker - Dr. David McCuan, "Protecting Our Democracy in Times of Strife: Guidelines & Guideposts for 2024"

DR. DAVID MCCUAN is Professor of Political Science and Department Chair at Sonoma State University. He joined the SSU faculty in fall of 2003 during the historic California recall election period.

Professor McCuan's scholarly expertise rests in two broad areas: American politics and international relations. He teaches courses in international and national politics, state and local politics, campaigns and elections, political behavior, and international security and terrorism.

In the area of elections, his research focuses on the general impact of ballot measures—direct democracy—in


California and across the nation. He has served as an expert witness in cases concerning direct legislation in both California and Washington state, where he has presented his research.

In addition to his work at SSU, Professor McCuan has taught at the California Maritime Academy and was a Visiting Fellow at U.C. Berkeley in the Institute of Governmental Studies (IGS) and the Graduate School of Journalism. He was a member of the Advisory Board of the Initiative and Referendum Institute (IRI) in Washington, D.C. and has used his expertise as an elections observer in the Horn of Africa.

Join us in Supporting College of Marin Students

Student Emergency Assistance Fund (SEAF) Application Fee Fund

This year we will continue to support the Student Emergency Assistance Fund (SEAF) while adding a new program. COM has asked us to provide \$5,000 seed money to initiate an Application Fee Fund for students transferring to a 4-year institution. Whatever we raise above that amount will go to the SEAF.

SEAF helps students stay enrolled at COM by supporting students in crisis when they need it most. Examples include car repairs; eviction protection; basic needs of hygiene, food, and housing supplies; and school supplies. The SEAF supports students when they need it the most, enabling them to continue their education.

The Application Fee Fund helps students fulfill their educational goal of transferring to a 4-year college. COM has between 350-400 transfer students a year. An application fee of \$80, non-refundable, is required for *every* UC campus selected. This new fund will give the Transfer and Career Center Coordinator, Sofie Totapudi, the means to assist those most in need. Our initial gift will provide for 15-25 students to apply to two or three institutions and help COM evaluate whether this program needs to be expanded to assist more students.

One student story from Sofie Totapudi

"We had a student last year who had achieved a 3.9 grade point average in just two years. When it came time to complete her application, she was faced with a \$100 charge. Having maxed out her one credit card on food and rent, she didn't have the financial resources to push the 'submit' button. Personally, it was one of my hardest days at work."

If you haven't voted yet, then make sure you return your signed ballot or visit a vote center to vote in person today! Remember, you can vote at ANY vote center in

The LAST day to vote in the March 5, 2024 Presidential Primary Election is Tuesday, March 5th! Note: Within seven days of Election Day, the Registrar of Voters recommends that voters return their ballots to a secure drop box or vote center instead of using US Mail.


CALLING ALL PROS & CONS FANS!

Human trafficking is a scourge that circles our globe. Once thought to only affect other countries, the US has been shown to be one of the highest perpetrators of sex trafficking and is significant in its labor trafficking, as well. She took on the task of preventing human trafficking in 2014 as a trained volunteer for Shared Hope International and in 2018 founded Wisdom International: Help2Others. Across the years, Laurel's focus has remained on building "Prevention Before Harm" knowledge and skills against human trafficking into everyone's daily life through developing and delivering individualized, age and culture-appropriate trainings for clubs, schools, and agencies. She hosts community events with her partners: Survivors, Tribal Leaders, coalitions, law enforcement, victim services and legal services, with each sharing best practices to end human trafficking from all angles.
