Meet Rebecca Maxwell, LCSW September Monthly Meeting Speaker

Rebecca Maxwell, LCSW is the Director of Behavioral Health, Social Services, Education, and Inpatient Palliative Care at MarinHealth and has been with the organization since 2017. She began her career in healthcare over 25 years ago as a student research assistant while attending college at Stony Brook University in New York. After earning a Bachelor of Science degree in Health Sciences with a concentration in Public Health and Community Health Education, Rebecca went on to Stony Brook University's School of Social Welfare and earned a Master of Social Work. She is licensed as a clinical social worker in New York and California.

Rebecca has held various roles in public health and mental health including work as an intensive case manager for persons with severe mental illness who were court-mandated to treatment; a psychotherapist in a group practice treating children, adolescents, and families, with a focus on prevention and treatment of substance use disorders; and as a clinical social worker in psychiatric emergency services and inpatient psychiatric treatment for adults and adolescents. In 2013, she earned a permanent appointment as a teaching hospital clinical social worker by the State University of New York at Stony Brook and achieved honors and recognition in 2008 from the School of Social Welfare at Stony Brook University for service to the university and profession.

Prior to relocating with her family to California in 2016, Rebecca was the Assistant Director of Behavioral Health at John T. Mather Memorial Hospital in Port Jefferson, New York, where she was responsible for oversight of behavioral health care in their adult and adolescent inpatient psychiatric units and psychiatric emergency services. Under her leadership, Mather Hospital's Department of Behavioral Health was awarded 2016 Agency of the Year by the National Association of Social Workers New York State Chapter – Suffolk Division.



Meet Alison Howard Fall Kick-off Speaker

Alison Dana Howard has taught at Dominican University of California for 19 years and currently serves as the Co-Chair of the Division of Public Affairs and the Director of the Core Curriculum. She teaches courses on American Government, the Presidency, Congress, Politics and Media, Political Parties and Interest Groups and Campaigns and Elections. She received her M.A. degree in Political Science from the University of Oklahoma. Her research focuses on political communication, specifically presidential rhetoric including the State of the Union Address and unilateral executive actions, as well as art, politics, and culture. Alison has published articles in *PS: Political Science and Politics, American Behavioral Science, Journal of Political Science Education, Social Science Quarterly,* and *Perspectives on Political Science.* She is the co-author (with Donna R. Hoffman University of Northern Iowa) of *Addressing the State of the Union: The Evolution and Impact of the President's Big Speech* (Lynne Rienner Publishers, 2006). Alison is also a frequent commentator for the media on the State of the Union Address and has been interviewed by *National Public Radio, The SF Chronicle,* NBC Bay Area, and KCBS radio.

The League of Women Voters of California (LWVC) strongly opposes Governor Newsom's recent decision to seek an Article V constitutional convention. The proposal, encapsulated in SJR-7, seeks to add California to the states aiming to alter the U.S. Constitution, a move that comes without a clear structure or guidelines.

The Constitution is a living document, representing the fundamental tenets on which our democracy rests. The LWVC supports targeted and focused policy action to address gun violence and the damage it is doing to our children and our communities, but a constitutional convention is not the right approach.

Contact your legislators today and ask them to reject this dangerous path forward.

Chris Carson, LWVC Board President, explains:

Opening a Constitutional Convention puts every right, civil liberty, and the underlying value of our country at risk. There are no limits or guardrails to what can be changed during a Constitutional Convention and it opens the door to well-funded special interests buying access to change the Constitution to serve their purposes.

The uncertainty surrounding the nature of a Constitutional Convention cannot be understated. Former **Chief Justice Warren Burger** once expressed concerns about the ambiguity and danger, noting,

[T]here is no way to effectively limit or muzzle the actions of a Constitutional Convention. The Convention could make its own rules and set its own agenda. Congress might try to limit the Convention to one amendment or one issue, but there is no way to assure that the Convention would obey. After a Convention is convened, it will be too late to stop the Convention if we don't like its agenda.

Our key concerns include:

- •Threat to National Stability: Advocating for a Constitutional Convention plunges the nation into an era of unparalleled tension, uncertainty, and protracted legal battles that might irreversibly alter America's trajectory.
- •Shift of Power from the People: An Article V Convention would elevate the voices of politicians and special interests above those of ordinary people. Such a development could result in an unprecedented opportunity for the few to reshape the core principles of the country for the many.
- •Unbridled Convention Agendas: Historical precedents caution that a Constitutional Convention might not restrict itself to its original mandate and every right that we have as Californians and Americans would be placed at risk.

California should not take this enormous risk with the rights of every person who lives in our state. We urgently request the legislature and every Californian to reject SJR-7 and continue working with communities to find solutions to our challenges that do not put the very foundations of our state in peril. Tell your Legislators today that you oppose SJR-7.

Our voter education work has been focused on the August 29 Special Election to fill a vacant short-term seat on the Tiburon Town Council. September is National Voter Registration Month! Great time to check your voter registration status and update or re-register if needed. WHAT'S UP - VOTER EDUCATION AND OUTREACH — Robin Diederich and Pat Beaupre Becker

Lots of planning activities have begun in preparation for the fall months leading to March 5, 2024, the Presidential primary and November 5, 2024, the Presidential election. We also have vital local elections coming up in 2024.

VEO's goal for 2024 is to ensure every resident of Marin County is aware of the elections, is registered, if eligible, and has access to the information they need to give them confidence in making their choices.

As of October, 2022, 92 percent of eligible voters in Marin County are registered. We believe that there are individuals from marginalized groups who are eligible to vote but who are not fully participating in elections due to certain barriers. These high-potential voters may not have access to non-partisan information and don't feel well enough informed about the issues. They may think their vote doesn't matter or that the system is corrupt.

Our goal is to tackle these barriers to voting by partnering with trusted community organizations that see civic engagement as vital to creating community empowerment and to know that access to non-partisan information is crucial.

National Voter Registration Day is endorsed by the National Association of Secretaries of State, National Association of State Election Directors, the U.S. Election Assistance Commission, and the National Association of Election Officials.
