Some Background Information about the Monthly Meeting Speakers

Eddy Cumins is the General Manager of the Sonoma-Marin Area Rail Transit (SMART) District. As General Manager he is responsible for overseeing day-to-day operations of SMART's transit and freight services. Eddy is also responsible for the planning and construction of SMART's multi-use pathway network and rail extensions. Prior to joining SMART as GM in November 2021, he served as Chief Operating Officer for the Utah Transit Authority. Eddy earned a Master of Science Degree in Organizational Leadership from Colorado State University and holds a B.S. in Human Resource Development from Southwestern College.

The Marin County Student Elections Ambassador Program

One of the most important institutions in our democracy is our elections system, which entrusts individuals with the power to vote. The Student Elections Ambassador Program (SEAP) was designed to allow high school and college-aged students who live in Marin County to serve as a crucial link between the Elections Department and their peers. The SEAP has two main objectives: to pre-register and register Marin County students to vote, and to highlight the importance of youth engagement and participation in elections.

Ambassadors undergo training where they learn about the importance of youth voter participation, voting in Marin, and how to pre-register and register individuals to vote. Then through a peer-to-peer approach, Ambassadors educate their peers throughout the school year.

Announcing Guest Speaker - Jennifer Jones Austin, Esq. "Dismantling Structural Racism"



A fourth-generation leader of faith and social justice, Jennifer Jones Austin has fought for equity her entire life. As CEO and Executive Director of FPWA, an anti-poverty, policy and advocacy organization she has led and secured monumental changes in social policy to strengthen and empower the disenfranchised and marginalized. Ms. Jones Austin has chaired many influential boards and commissions, including the New York City Racial Justice Commission where she led the development and passage by the NYC electorate in 2022 of three unprecedented proposals to amend the city's charter to dis-

mantle structural racism and embed racial justice and equity in all government functions. She is Vice Chair of the Board of National Action Network and a founding member of the New York State 400 Years of African-American History Commission. Ms. Jones Austin also chaired the NYC Board of Correction presiding over the process to end solitary confinement in NYC jails and was a lead advisor for the 2020-2021 NYPD Reform and Reinvention Collaborative.

Student Ambassadors Celebrate Martin Luther King Day



On Monday January 16, 2023, a Rev. Dr. Martin Luther King Jr. Day celebration called "Beloved Community in Action" was held in Marin City. The event which was held at the namesake school, Dr. Martin Luther King Jr. Academy, gathered a diverse group of students and advocates coming out to support. There were performances by students from the school and booths were set up in the auditorium. One of them, which was also a sponsor for the event, was County of Marin Office of Equity led by the Marin County Student Elections Ambassador Program. Student liaisons Alysha Lee and Ella Clark took the lead to spur attendees to take action. The mission of the Student Elections Ambassador Program is to educate about the importance of voting and to assist eligible vot-

ers, especially high school and college students, to pre-register or register to vote. Younger students in elementary or middle schools also got a glimpse of what voting was about that day. With over 200 people attending, this event was a true community collaboration to honor the legacy of Dr. Marin Luther King Jr. in a unified way.



Our help is needed to keep College of Marin students in school!

None of us had any idea of the tidal wave of need that was to come from students at College of Marin (COM) due to COVID-19 impacts. The Education Foundation decided to do what it could to help.



In 2020, 2021, and 2022, the Education Foundation -along with donations from many League members and friends -- was able to send a total of \$31,000 to the Student Emergency Assistance Fund (SEAF) for COM students.

As we come out of the pandemic, those with the greatest need continue to be students of color, low-income students, and students with disabilities.

Our work is not done.

Once again, the Education Foundation will match your donations with an equal grant of up to \$6,000.

- Our assistance has helped keep students in school by providing technology, book purchases, and short-term support for personal needs.
- In addition to laptops, the emergency fund has already spent \$4,800 in the campus bookstore for students' textbooks.
- The fund has been invaluable to COM's ability to meet students' needs swiftly with a minimum of red tape. That could mean replacing a flat tire, paying for unexpected medical expenses, providing short-term childcare, or any other challenge that jeopardizes a student's ability to get to class.

School and Library Boards and Commissions Diversity Study

The **Education/Libraries Committee** is embarking on a new local study with the goal of supporting increased diversity on school and library boards and commissions. Our aim is to use an equity lens to map out the factors that impact an individual's election or appoint-

ment to a school district or library governing board or commission in Marin County. At the conclusion of our study, the committee will consider and recommend possible solutions to removing barriers and increasing equity on these boards.

We will begin by gathering information on the democraphic make-up, both current and historical, of our local school and library boards in order to document any racial, ethnic, gender, age, and socioeconomic disparities. We will also explore systemic and structural barriers that may have contributed to the disparities. Much of our learning will be through conversations with individuals who have been impacted by these barriers, including those who have overcome them to serve on boards, and community members who have been involved in efforts to increase board diversity.

We invite you to join us in this new and exciting endeavor! Our committee meets the third Thursday of the month at 10:00am. The next meeting is March 16.

Monitor and Provide Input:

San Rafael Transit Center Project Highway101/580 Connector Project Highway 37 Corridor Project SMART Train System – Building Community Support

Work Plan: Ongoing monitoring of projects by working with project staff, public officials, community organizations and examining information on websites including how these projects are or will be impacted by sea rise. Consult and Coordinate with Bay Area League in provid-

ing written and oral comments as appropriate.

Advocate for Regional and Local Cities and Towns support and an Implementation for Vision Zero or similar Programs resulting in Safer Environment for Drivers, Cyclists, and Pedestrians.

Work Plan: Work with regional and local government officials and their staff in advocating for Vision Zero or similar programs for their communities. Provide written or oral input as appropriate

Monitor and Provide Input Regarding Future of Public Transit Systems in North Bay

Work Plan: Monitor activities of Metropolitan Transportation Commission regarding the future of public transit in the Bay Area with special interest to public transit systems serving Marin County. Special emphasis will be regional coordination of transit funding and operations and how these issues will impact local riders.

Coordinate positions and advocacy strategies with the Bay Area and State Leagues. Meet with transit system managers and community organizations representing local transit riders. Provide written or oral input as appropriate.

2023 Housing Goals

Continue Education and Advocacy of Affordable Housing in Marin

Work Plan: Work with government officials, their staff, community groups and builders supporting the construction of affordable housing in Marin. Meet with and/or communicate with elected officials and City and County staff to advocate support for these projects.

Monitor and Advocate for Effective Implementation of the State Approved 12 Housing Elements in Marin and Related Local Legislation.

Work Plan: Survey the status and perform ongoing monitoring of approved housing elements of the Marin cities and towns and those of the County. Work with local elected officials and their staff to ensure progress and compliance with those elements.

Advocate and Support Efforts by Marin Cities and Towns and the County to Develop Effective and Efficient Solutions for the Homeless and the Unhoused Persons in their Communities.

Work Plan: Monitor the status of Homelessness in Marin Communities and advocate and assist local jurisdictions in their efforts to acquire funding for these programs as well as community support in implementing the programs.

Urge State League to Advocate for the Planning and Construction of Affordable and Market Rate Housing.

Urge State League to Monitor the Status of Related Housing State Legislation and to coordinate that Information with the Local League Chapters. Also consult and work with Bay Area LWV on the work of Bay Area Housing Finance Authority's (BAHFA) affordable housing efforts.

Work Plan: Work closely with State League and LWV Bay Area in developing strategies and legislation that result in more affordable and market rate housing being built.

February Committee Meeting

Housing Issues

Update and discussion of Status of Marin District's Housing Elements - Discussion leader: Bob Pendoley

Committee member Pendoley noted that the Marin County, cities and towns had until January 31 to submit their Housing Elements. Some met the deadline, not all are in compliance, and a few "self-certified." Bob described the consequences of this, the "Builders Remedy" Law, which allows for developers to get building permits if a city's Housing Element has not been certified by the State. He cited, as an example, the City of Santa Monica, where the city missed the deadline, so developers got permits for 4000 units to be built.

Committee members discussed the difficulty of these requirements. Bob noted that as of this date, in the Bay Area only San Francisco, Alameda and Emeryville are in compliance.

Action: The Committee will continue to monitor this process and agrees that it is important for League members to encourage their jurisdictions to continue to work with the State to get their housing elements approved and once approved implemented.

Transportation Issues

Guest Speaker: Molly Graham, Public Outreach Coordinator, Transportation Authority of Marin (TAM)

Update on New Funding for Marin Transportation Projects

Ms. Graham provided the Committee with an update on Transportation Funding for Marin County. Recently, the California Supreme Court provided a favorable ruling on RM3 (Bridge Tolls revenues). This action will result in Substantial funding for San Rafael Transit Center Project, the US Highway 101 to Highway 180 Connector Project, the Sonoma/Marin Narrows Project and the SMART expansion projects to Windsor and Healdsburg.

Ms., Graham also reported the Golden Gate Bridge and Highway District received Hundreds of Millions of Dollars in Federal Infrastructure funding for the Golden Gate Bridge

Update on Northbound Highway 101 to Eastbound 580 Connection Project

Ms. Graham provided an overview of TAM. She gave the Committee an update on the newly re-named 101-580 Multimodal and Local Access Improvement Project. The project includes a new freeway-to-freeway connection between NB US 101 and EB I-580 to improve connectivity and traffic flow for local and regional traffic. The Committee had questions about a Southbound Connector, the impact of the project on San Rafael residents, the environmental impact, and the length of time and dollars needed to make this project work for the people most impacted.

Action: Committee members will continue to monitor this project closely and encourage TAM to continue to consider the impact of the project on all users, including under-represented communities and the older populations in Marin.


I tuned into the LWVUS Birthday virtual pep rally. It was a ZOOM meeting that was streamed live on Facebook.
